X. Board Report: Dr. Agana reported that the American Academy of Pediatrics Foundation in coordination with the Trumbull County Combined Health District is sponsoring a gun safety program wherein gun safety locks will be provided through Cabela's and Kiwanis Clubs. This event will be held the last week in September. The Trumbull County Combined Health District is the first public health department to participate in this type of initiative, and Dr. Agana thanked Mrs. Swann and Mr. Migliozzi for their cooperation with this program. No health department funds will be outlaid for this program, all funding will be from the American Academy of Pediatrics Foundation.

Mr. Messersmith stated that last October or November, he was asked to investigate the possibility of the health department relocating. Mr. Messersmith stated that he had spoken with the county commissioners, who referred him to Atty. Jim Misoky. Two (2) places were discussed with regard to relocating, but it would require the department to split, and Mr. Migliozzi did not feel that that was a good idea for the department.

Mr. Biery introduced Mr. Dubos as the Board new member, and welcomed him to the Board. Mr. Biery also recognized Mr. Appis, who was in attendance at the meeting, and thanked and recognized him for his many years of service on the Board.

B. Update – Declaration of Unfit for Human Habitation – 6501 St. Rt. 87, Kinsman Twp. – Peter Fedak, Owner – At the December 16, 2015, Board of Health meeting, this property was brought before the Board. At that time, the Board tabled the matter to allow Mr. Fedak time to work out a compliance schedule with the health department to remediate the issues on the property. Mr. Hedge stated that he conducted a re-inspection on March 7, 2016. Mr. Fedak has cleaned the site and made some structure repairs. At this time, the structure, in its current state, does not meeting the standards to be declared unfit. A notice was sent to the Kinsman Township Zoning Inspector notifying him of the findings.

Mr. Messersmith stated that he had concerns over variances being brought to the Board. In particular, for a sewage system on a Custer Orangeville property on last month's agenda was brought before the Board for variance, for a sewage system that had already been installed, but the write up stated that a variance was required prior to a permit being issued. Further stating that he felt that the Board was being used when someone is asking for a variance for a the system that has already been installed, and that he was against these types of matters being handled internally. Mr. Migliozzi responded stating that the variance write up was written up incorrectly, and it should have said before the system could be finalled it needed a variance from the Board. At times, as an installer runs into problems when installing the system, which requires a variance before the inspector can give a final approval on the installation. Mr. Migliozzi made it clear that variances are not being handled internally, administrative hearings are the only matters that were being brought before the Board that are now being handled internally.

XII. New Business: A. Passage of Revision of the Trumbull County Combined Health District Fee Schedule - .12 Tattoo Establishments – 1st Reading – The environmental division conducted a cost analysis of the tattoo program. Currently the tattoo establishment registration fee is \$150.00, based upon the cost methodology; the new fee will be \$276.20.

Most boards of health do have public comment, but there are restrictions such as the use of sign in sheets five (5) days advance notice if the person wishes to speak regarding a particular property and amount of time allotted for speaking.

In the by-laws, it specified an employee welfare committee whose duty it would be to approve leave for the Health Commissioner. Instead, it was suggested that the Board Chair and Vice-Chair be authorized to approve leave for the Health Commissioner.

E. Variance Request – Dan Clonch – Mr. Clonch is requesting a variance from OAC 3701-29-03(C)(5) for 2016, which states "...beginning with registration years starting on January 1, 2016, proof of completion of at least six continuing education hours during the previous calendar year through educational programs approved by the department of health or demonstration of competency obtained..." Due to several medical issues in 2016, Mr. Clonch was unable to obtain and complete his required six (6) continuing education hours. Mr. Clonch has signed up to take the health department's wastewater operation class on March 30, 2016, and is aware that he will need to obtain an additional six (6) hours before the end of 2016 for his 2017 registration.

F. Recently IRS Decision Declaring Board of Health Members Employees – A letter was recently received from the Trumbull County Auditor stating that Board of Health Members are considered employees, and would need to pay federal and state taxes, and possibly PERS. This IRS ruling directly affects one of our current Board Members, who is a PERS retiree, and puts their health insurance coverage in jeopardy. It is the health department's position that the definition of public employees, exempts board of health members, and therefore board of health members would not be PERS eligible. The Trumbull County Prosecutor's office was contacted, and it is their opinion that this is a private matter, and the health department cannot use health department funds to investigate this matter. The Association of Ohio Health Commissioners has agreed to pay an attorney, who has researched this matter, to fight this issue for our Board Member. Mr. Biery questioned what happens in the meantime while this is being sorted out. Mrs. Salapata replied that she still have insurance coverage, but is paying more for it, and she lost the reimbursement she was receiving for her spouse. It is hoped that this matter will not be drawn out, and it will be remedied soon. Mr. Biery asked if the Board should send a letter of support. Atty. Kokor advised that the Board wait, until the attorney addresses the matter first. Mrs.

Salapata stated that PERS knows the law is in place, but their answer has been "...yes, but..."
