**Health Commissioner Report:** The combining of the Niles City Health District with the Trumbull County General Health District was approved by the Trumbull County Health District Advisory Council at a special meeting held on August 12, 2015. Currently the districts are working on executing a formal contract. With the combination of the two health districts, two Niles City Health District employees, Michael Burke and Teresa Merrick, joined the Trumbull County General Health District staff, and a new Board Member representative from Niles City, Kathy Salapata, were introduced to the Board.

**Director of Nursing Report:** The Healthy Families America Accreditation Standards for the health department's home visiting program were due August 3, 2015, and were submitted. The health department should know some time in September if our program passed accreditation. The Board Members were reminded that, per Ohio Revised Code, each member must annually complete two hours of continuing education pertaining to ethics, public health principles, and a member's responsibility. Each member was provided a DVD from the Ohio Association of Boards of Health, which contains ten modules pertaining to boards of health, and a verification sign off sheet. Each module on the DVD is 15 to 20 minutes long, and the completion of all ten modules will meet the continuing education requirements. Once a Board Member views all ten modules, they are to sign the verification form and submit it to Sandy Swann.

Dr. Agana complimented the Home Visiting Program Staff for their efforts and work they do with the children and parents in the community.

**Health Educator Report:** The Annual School Food Service Conference was held on August 12, 2015, at LaBrae High School. 80 participants from approximately 20 school districts throughout Northeast Ohio attended. The health educator assisted and/or participated in the following Creating Healthy Communities Grant activities: Installation of security lighting and painting of all equipment at Bolindale Park. Bike mounds have been built and climbing nets installed at Woodland Ave. Park . SCOPE mobile food pantry began deliveries to homebound senior citizens on July 13<sup>th</sup>. Howland Farmer's Market has begun offering the "Double Up Incentive" program, which puts money back on EBT/SNAP users cards based upon the amount of fresh produce they purchase. The CHC Coalition held its 3<sup>rd</sup> quarterly meeting and grant planning meetings for the 2016 application will be starting. Ms. Amerine assisted with the Community Health Assessment Surveys at the Trumbull County Fair, and will be attending the Johnson Community Trail Ribbon Cutting on September 4, 2015 at 4:00 P.M.

**Director of Environmental Health Report:** The new procedure for "Issuing Orders & Prosecuting Nuisance Complaints" was presented to the Board. Algal Blooms and water protection is a serious issue, and September 8, 2015, has been declared Protect Your Groundwater Day. Mr. Migliozzi will be working with representatives from the sanitary engineer's office and emergency management to develop a countywide protection plan. The health department is nearing its deadline for its first round of document submission for accreditation. Many items will be coming before the Board for review and approval/adoption. In addition, several staff members will be attending Lean Ohio Boot Camp in September. Dr. Agana asked for the dates and information, so she may possibly attend also.

**Board Report:** Mr. Biery appointed John Messersmith to serve as Chair on a building committee with health department division leaders and union stewards, to investigate the requirements of a new health department building.

Dr. Agana requested that the Board address the health department's financial audit. Dr. Enyeart replied that the final audit had not yet been released and it was confidential until the Auditor of State officially releases it. Atty.
