- I. The meeting was called to order and the Pledge of Allegiance was said.**

- IV. Health Commissioner Report:** Dr. Enyeart informed the board that Niles City Council met and voted unanimously to combine with the Trumbull County General Health District. A contract is being written for review, and the Chairman of the District Advisory Council has been contacted. The District Advisory County will be scheduling a special meeting to vote on this amalgamation.

- V. Director of Nursing Report:** Mrs. Swann presented a written report to the board for their review.
- VI. Director of Environmental Health Report:** Mr. Migliozi presented a written report to the board for their review. In addition, Mr. Migliozi updated the board of Lafarge and discussed accreditation, informing the board that the Workforce Development Plan is near completion and will be brought before the board for adoption in August. Mr. Migliozi stated that approximately 1,000 documents will need to be gathered and submitted to PHAB by February 2016, and commended Natalie Markusic, the Accreditation Coordinator, and the rest of the staff on working together toward this common goal. Dr. Agana also commended the staff on the work they are doing towards accreditation, stating that she attended one of the Domain meetings and witnessed the work the staff is putting into this effort. Mr. Messersmith questioned as to whether the merger with Niles will affect the accreditation process. Mr. Migliozi stated that it should not affect the health department obtaining accreditation, and that the two staff members coming from Niles will be added to Domain teams.
- VII. Health Educator Report:** Ms. Amerine provided a written report the board for their review. In addition, Ms. Amerine informed the board that the final CHANGE Report of the 3 target communities had been completed, and supplied the board members with a copy. Currently Ms. Amerine is working with Howland Park Board and the Howland Wellness Committee for the Bolindale Park Clean-Up. A draft survey has been created to survey residents' views and attitudes on smoke-free housing that will be given to residents in 3 target communities July through November. The Annual School Food Service Conference will be held on August 12, 2015 at LaBrae High School and registrations are now being accepted.
- VIII. Board Report:** At this time, Mr. Simon stated that at the last meeting he had spoken about a letter that he had written regarding having the county's consent agreement listed. Mr. Simon apologized to the board if he did not follow the proper protocol, stating that he was not suggesting that he send this letter out on his own, but with the cooperation of the board members. Mr. Simon stated that he did reach out to several installers to ask for comparisons but, and only found one that did work in the surrounding contiguous counties. Mr. Simon also reached out to the Ohio Attorney General's office and the Ohio EPA for their opinion on how best to handle this matter. Mr. Biery appreciated the "tweaking" that Mr. Simon did in writing the letter. Mr. Messersmith stated that he felt it best to get the Ohio EPA and Ohio Attorney General's guidance as to how to accomplish this. Mr. Biery asked that a committee be formed with Dr. Agana, Mr. Simon and himself, with Dr. Enyeart and

Mr. Migliozi to attend and offer advice. Mr. Messersmith stated that it was wise to get their guidelines first as to how to accomplish this endeavor. Mr. Biery thanked Mr. Simon for his efforts.

G. Alleged Code Violation – Robert Mitchell, 1148 Cedar, Braceville Twp. – Not present. As a result of a real estate evaluation, the septic system was inspected on December 6, 2010, and no septic components of any type were found. A notice of disapproval was issued on December 7, 2010, July 6, 2011 and January 17, 2012. On August 23, 2012, a director’s hearing was held, but no one attended. On September 9, 2012, the board of health issued orders to identify any and all system components, but the owner did not comply, and on February 7, 2013, charges were filed in municipal court. On January 13, 2014, paperwork was received for the installation of the system, and a preliminary specification sheet was drafted on January 16, 2014, but no further action was taken. On February 20, 2015, a 30 day notice to proceed with the replacement of a system was issued and on May 19, 2015, an in-house hearing was scheduled, but no one attended.

As a result of a property transfer search, it was determined that the property was transferred without an inspection of the sewage system, which is a violation of OAC 3701-29-19(B) and Trumbull County General Health District septic policies.

MOTION: 15-144 made by Mr. Messersmith, seconded by Mr. Appis to require Darrell Moody to make arrangements to have the sewage system evaluated at 1165 Greenville Rd., Mecca Twp., within 14 days. Furthermore that the board of health authorize the health commissioner, pursuant to ORC 3709.091, to cause assessment to be filed against the property owner for failure to pay the required inspection fee in the amount of \$312.50 (\$250.00 inspection fee & \$62.50 penalty fee) if the owner does not comply with the 14 day notice. After this has been completed, an inspection of the sewage system will occur.

Mr. Simon questioned if Mr. Moody submits the paperwork and the fee within 14 days, the cost of the fee would be the \$250.00. Mr. Migliozi replied that would be correct.

I. Alleged Code Violation – Robert Ledyard, Parcel 60-031585 St. Rt. 87, Mesopotamia Twp. – Mr. Ledyard was present & sworn. As a result of a nuisance complaint, the property was inspected on August 4, 2014. At the time of inspection, tires, shingles and other miscellaneous debris was openly being dumped on the property, and a notice of violation was issued. Re-inspections occurred on October 20, 2014, February 19, 2015 and March 31, 2015, to determine if the owner had complied with the orders, but the inspector noted that very little progress had been made. Mr. Ledyard stated that the property had been under water. He had been over and cleaned some of it up, but because of the flooding he was not able to do anymore at this time. Mr. Ledyard also stated that he had submitted receipts to for some of the clean-up that he had done. Mr. Hedge stated that he had not received any receipts since March. Mr. Hedge stated that the property is right at the Bloomfield-Mesopotamia line, and is a very wet area. Mr. Ledyard asked if the board could contact the Army Corp of Engineers to come and help due to the flooding. Mr. Migliozi stated that the Ohio Department of Natural Resources would need to be contacted to see if they could relocate a beaver dam, but Mr. Ledyard needs to clean up the property. Mr. Ledyard asked if he could get dirt to fill in the area. Mr. Migliozi responded that he really needed to check with the Army Corp of Engineers before he started filling in areas on the property.

L. Alleged Code Violation – James G. Evans III, 2149 Ewalt, Howland Twp. – Mr. Evans was present and sworn. As a result of a nuisance complaint, the property was inspected on April 16, 2014. During the inspection, it was noted that the property owner was harboring a large amount of cats with food and water left outdoors to attract them. This matter was to be heard at the March 2015 meeting, but the owner called to discuss the issues. At that time, the owner was instructed to stop placing food outdoors that was attracting cats and wildlife, and to trap and remove the cats. On April 15, 2015, a re-inspection was conducted, but no progress had been made. Mr. Evans asked what he needed to do to resolve the issue. Mr. Hedge responded to Mr. Evans that he needed to cease and desist feeding and giving the cats water. Mrs. Swann and Dr. Enyeart both cautioned Mr. Evans and informed him of the hazards of harboring feral cats.

Following discussion, Mr. Evans questioned a complaint that had been made regarding his neighbor who was remodeling his home, but had no electrical or sanitary hook up, and questioned as to why he would be allowed to circumvent the law. Mr. Migliozi asked Mr. Evans to provide him with an address and he would check to see the status of the file. Mr. Evans stated that he was 2129.

MOTION: 15-146 made by Mr. Messersmith, seconded by Dr. Agana to require James G. Evans III to cease and desist in the harboring of cats on the property located at 2149 Ewalt, Howland Twp., by not placing food and water in an outdoor location so as to attract them to the property; this is to occur within 7 days. The owner is also to contract with a licensed trapper to remove the stray cats from the property; this is to occur within 45 days. Failure to comply with this order shall result in the matter being referred for appropriate legal action.

N. Alleged Code Violation – William Fuller, 3548 Birchwood, Howland Twp. – Mr. Fuller was present and sworn. Mr. Fuller’s son, Joseph Fuller, was also present. As a result of a nuisance complaint, the property was inspected on October 22, 2104. At the time of inspection trash and other miscellaneous debris was openly being dumped on the property. A notice with orders to remove the solid waste was issued, and a re-inspection was conducted on January 8, 2015, but the owner had not complied. An in-house hearing was scheduled for February 12, 2015, but the owner did not comply with the agreement. Mr. Fuller was to meet with the inspector to itemize all items and develop a plan of correction. On April 15, 2015, a follow up inspection was ducted and it was determined that compliance was not achieved. Mr. Fuller stated that his son had had a motorcycle accident, and due to his son’s disability and the weather, clean up had been slow. Mr. Fuller did say though that the car had been removed and gave receipts to Rod Hedge for some of the clean-up.

At the time of inspection, construction & demolition debris and other miscellaneous debris was openly being dumped on the property. A notice with orders to remove the solid waste was issued, but the owner did not comply. An in-house administrative hearing was scheduled, and the owner agreed to work with the inspector to develop a compliance schedule, and an additional 60 days was given, and then the owner requested an additional 30 days. Re-inspections occurred on August 8, 2014 and April 14, 2015, but the owner had not complied with the orders. Mr. Glass stated that he was on total disability, but was trying to clean the property up. Mr. Glass also stated that he had been told by the township police that anything behind the fence was okay, and he had 90% of the slag spread. Mr. Hedge showed more recent pictures to show what was behind the fence, which was of concern. Mr. Glass reiterated that he was told as long as it was behind the fence it would be okay. Mrs. Swann explained to Mr. Glass that part of the problem is that what he has is a breeding ground for mosquitoes. The health department’s concern is not whether people can see what he has behind the fence, but the possibility of the spread of disease through the insects. Mr. Hedge added that just because he has a fence up, it does not mean that he can openly dump solid waste on his property.
