



TCCHD Evening Covid Vaccine Clinics August – September 2022

(Walk-in from 5:00PM - 7:00 PM)

Trumbull County Combined Health District (TCCHD) will be hosting evening Vaccine clinics during the months of August-September, offering all COVID-19 vaccines (Moderna, Pfizer, Johnson & Johnson, and Novavax). These include second boosters for aged 50 and older, and those 12 and older who are immunocompromised.

These are walk-in clinics, and no appointment is necessary. To speed up your check-in process we are strongly encouraging everyone to visit our website (www.tcchd.org) to download, print, and complete the COVID-19 Vaccine Administration Record form and bring the completed form to your appointment.

If you are receiving your additional or booster dose, please be sure to bring your vaccine card with you to your appointment. If you are under an Ohio managed care Medicaid plan, you may be eligible to receive a gift card through the mail, for a Moderna or Pfizer booster. Information will be provided at the clinic.

Please note that the Pfizer vaccine is for individuals 12 years and older and the Pfizer pediatric vaccine is for individuals 5 – 11 years old. A parent must be present with all minors for them to receive the vaccine. The Moderna, Johnson & Johnson, and Novavax vaccines are for individuals 18 years and older.
